
Dear Mr. Patterson,

Re: Response to your testimonial

Dear Ms. Bolger;

Thank you for the testimonial, and having faith in our ability to assist you in your child support collection efforts. Like many cases we take, we felt terrible that you previously had no success in your collection efforts. Because your child's father lived in the State of Texas, there was a chance that his driver's license was not suspended by New Jersey. Since he had not filed any taxes, none of the enforcement actions offered by the Office of Child Support Enforcement could or would compel him to pay years of past due arrears. Our thorough investigative efforts determined his residence, and confirmed he was receiving mail at that address. Our investigative report and the attorney's certification, proved to the court that he received the motion we filed for your Child Support Enforcement Order. The [Enforcement Order](#) provided provisions for all fees to be paid by Kyle Bolger, to prevent any fees being deducted from your child's support.

I believe the conditions we requested in your motion for your Child Support Enforcement Order made his parents realize we were serious, and caused them to provide information to assist in our enforcement and apprehension efforts. Since the enforcement order issued includes all future arrears, he can be continuously apprehended by our fugitive recovery agents, and extradited back to New Jersey should he fail to make any future payments.

I believe your case is a shining example of our ability to service custodial parents who are owed arrears.
